

He continues to be recognized for his contributions and leadership – in addition to the Cornerstone Award he has been honored by the National Historic Trust for his contributions to historic preservation and Texas Wesleyan University named him as their 2007 Executive Man of the Year for their Business Hall of Fame.

Initially FourPoint Energy will geographically focus in the core areas of the Western Anadarko and Permian Basins. Served on the Board of Directors of Western Energy Alliance (formerly IPAMS) from 1998 to 2012 and on the Executive Committee since 2002, serving as president in 2009 and 2010. Also serves on the Advisory Board for the J.P.
